Jonathan has appeared in hundreds of intellectual property cases pending in the United States District Court for the District of Nevada and in other federal courts located throughout the country. He principally handles trademark, copyright, and patent infringement cases, as well as cybersquatting, trade secret, and internet litigation. He obtains and defends against requests for injunctions and obtains emergency court orders permitting the seizure of counterfeit and infringing goods displayed at major Las Vegas tradeshows, such as CES, SEMA, AAPEX, and Magic. He recovers disputed internet domain names and websites and handles online infringement and defamation claims. In addition to litigating intellectual property cases, Jonathan regularly litigates complex business cases, including franchisor-franchisee disputes, corporate ownership and control disputes, and disputes involving breach of contract, fraud, and tortious interference claims.
